


"In case the date of opening of bids happen to be a holiday, then the bids shall be opened on the next working day of the same time.

TERMS AND CONDITIONS:

1. **Scope of works:** Details enclosed at schedule as Annexure-III.
2. Bidder (s) can inspect the Items awaiting disposal between 10.30 A.M. to 05.30 P.M. on working days at Rajendra University, Balangir premises in regard to the conditions, quality etc of items and satisfy themselves before submitting the their offer by the date and time specified.
3. Over writing or alteration will also disqualify the bids unless these are legible attested by bidder/bidders.
4. It will be presumed that the bidders before submitting the offer have read carefully all the terms and conditions and accepted the same in full, deviations from the terms and conditions as given in this are not permitted. Any such conditional bid and/or telegraphic bid is liable to be rejected. No counter terms and conditions shall be accepted.
5. Right to include, notify, or alter any of the bid conditions already stipulated is reserved by the competent authority, Rajendra University, Balangir.
6. All goods will be sold on "**AS IS WHERE BASIS**". Bidder will be deemed to have been on the clear understanding that they have satisfied themselves fully in regard to the conditions, quality and quantity of unserviceable items proposed to be auctioned.
7. A sum of **Rs. 8,770/-** (Rupees Eight Thousand Seven Hundred Seventy only) shall be deposited by the intending bidders in shape of Account Payee Bank Draft drawn in favour of the "**Comptroller of Finance, Rajendra University, Balangir**" and submitted along with the tender as EMD. After completion of tender process, EMD shall be refunded to the unsuccessful bidders.
8. In the event of non-removal of the materials the EMD of the Successful bidder will be forfeited and he will not be allowed to participate in future for such sale.
9. The successful bidder whose bid will be accepted shall have to deposit the offered amount within 05 working days & to lift the material from Rajendra University, Balangir premises failing which the offer will be cancelled & EMD will be forfeited. The EMD shall be refunded after receiving the offered amount in the saving account having number.
10. If the bidder fails to remove the materials within the time limit, the ground rent @ 1 % of the bidding amount will be charged for each day till removal of the article up to maximum of 10 % of contract value.
11. The competent authority reserve the right to accept or reject any or all of the bids without assigning any reason thereof.
12. If two bidders quote equal rate, then final bidder will be selected through lottery.
13. Any expenses towards transportation & manpower etc, will be borne entirely by the successful bidder.
14. The bidder shall not be allowed to transfer, assign pledge or sub-contract its rights and liabilities under this contract to any company/firm/bidder without the prior written consent of this University.
15. The University reserves the right to terminate the contract at any time, if required.
16. In the event of failure to accept the offer of contract by the successful bidder for whatsoever reason(s), Earnest Money Deposit submitted by the bidder shall be forfeited.

17. The University shall not be responsible for any financial loss or other injury to any person deployed by the contracting firm in the course of their performing the duties to this University in connection with any contract with Rajendra University.

18. **Submission of quotation** - All sealed quotations must be dropped in the drop box kept at office of Administrative Block, Rajendra University, Balangir or to be sent by Speed /Registered Post on or before the scheduled date & time. The quotations received beyond scheduled date & time will not be acceptable at any circumstances. Rajendra University. will not responsible for any postal delay. The quotation must be addressed to "**The Registrar, Rajendra University, Balangir, Prajna Vihar, Balangir-767002**", so as to reach within the specified period.

19. **Settlement of Disputes:** In the event of any dispute or differences between the Rajendra University, Balangir and the bidder, arising out of non-supply of material or goods, not found as per specifications or any other cause whatsoever relating to the supply or purchase order, before or after the supply has been executed, shall be referred to the Registrar, Rajendra University, Balangir. who may decide the matter herself or by constituting a committee or may appoint Arbitrator under the Arbitration and Conciliation Act, 1996. The decision of the committee/competent authority shall be final and binding on both the parties. All disputes shall be subject to jurisdiction of courts at Odisha only.
